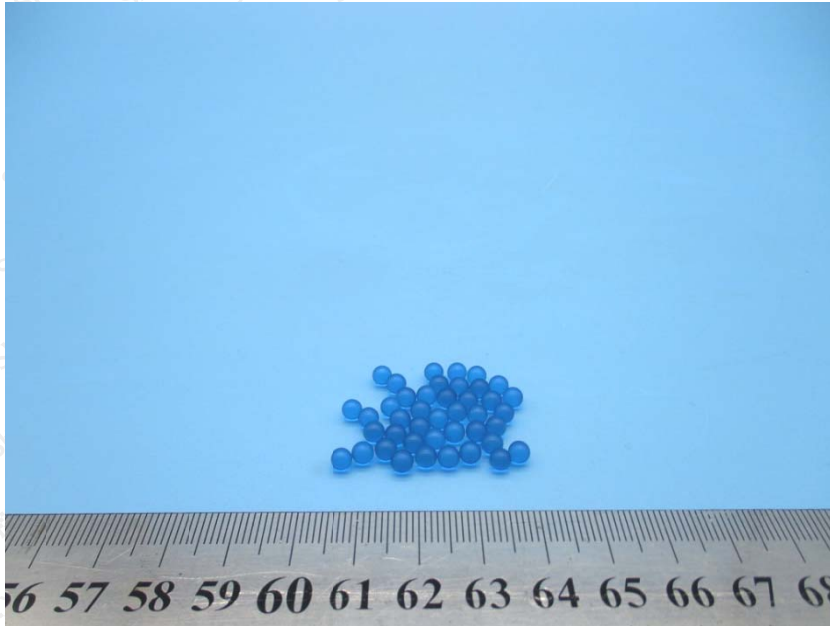


Figure 5. Peach

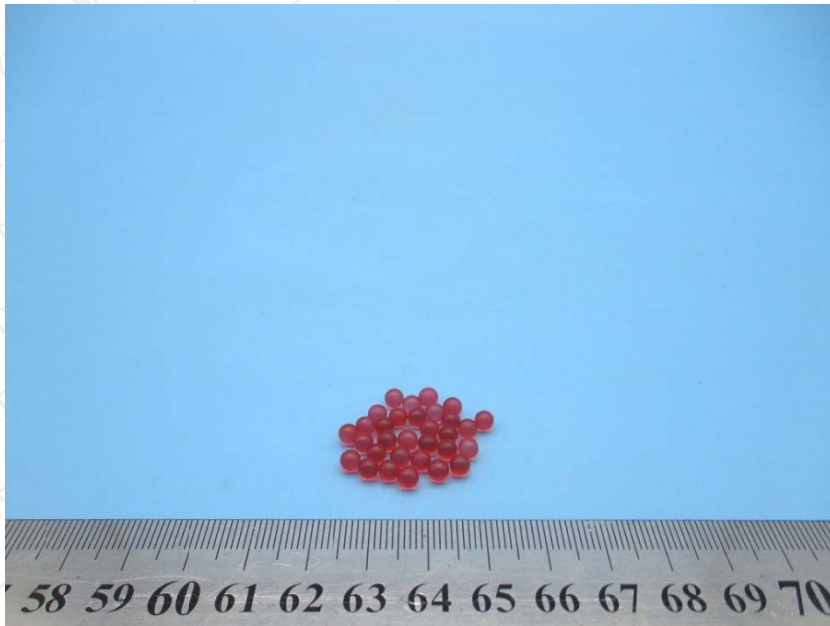


Figure 6. Strawberry

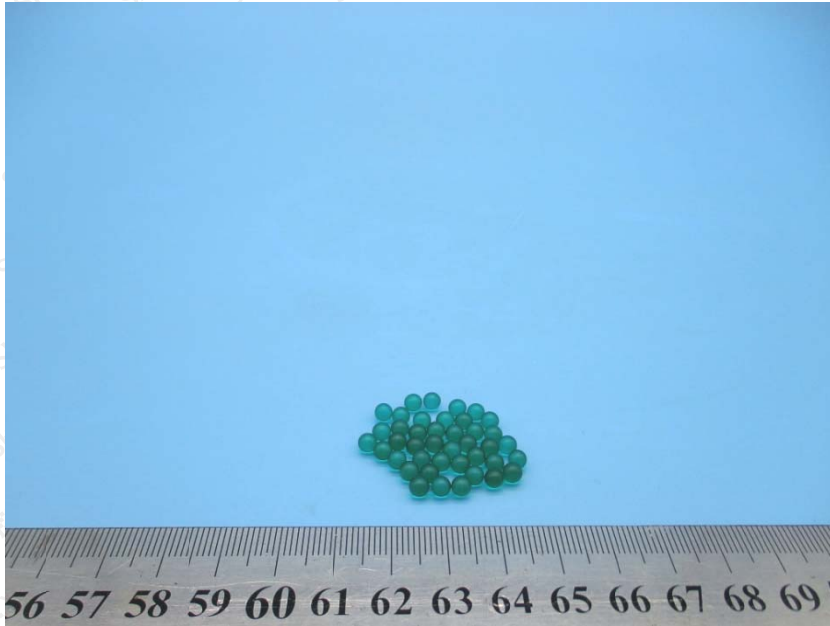


Figure 7. Cantaloupe

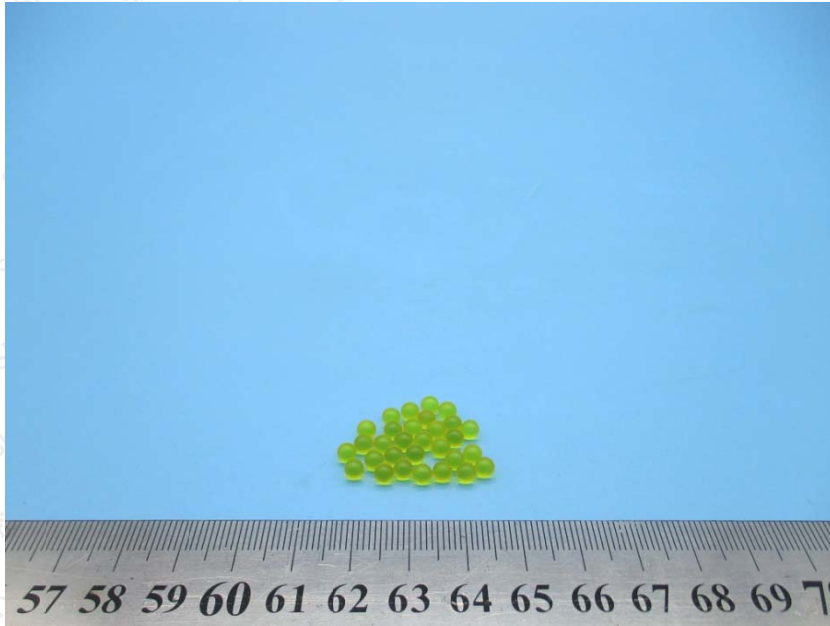


Figure 9. Mango
